

BOROUGH OF CRESSKILL

ORDINANCE NO. 17-07-1501

AN ORDINANCE TO AMEND CHAPTER 263 - VEHICLES AND TRAFFIC

WHEREAS, the Mayor and Council of the Borough of Cresskill desires to increase safety on public roadways and with the recommendation by the Cresskill Police Department, Traffic Bureau Division;

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Cresskill, in the County of Bergen and State of New Jersey, as follows:

SECTION I:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by deleting the following:

SECTION 263-32. Schedule I: No Parking.

In accordance with the provisions of Section 263-7, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Name of Street	Side	Location
Grant Avenue	North	From Tenakill Brook west to the Borough line
Grant Avenue	North/East	From Tenakill Brook to the east end of Grant Avenue
Madison Avenue	North	From Brookside Avenue to 100 feet west of Jefferson Avenue
Madison Avenue	North	From Cresskill Avenue to east entrance of Fire House
Madison Avenue	North	From the railroad tracks to Cresskill Avenue
Madison Avenue	South	From Eight Street to Sixth Street
Madison Avenue	South	From Monument Circle east for 100 Feet

Madison Avenue	South	From Piermont Road to drive-way of 12 Madison Avenue (curb to be painted yellow)
Madison Avenue	South	From the railroad to Cresskill Avenue

SECTION II:

SECTION 263-32. Schedule I: No Parking.

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

In accordance with the provisions of Section 263-7, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Allen Street	North	From Union Avenue to east edge of #37 Allen Street
Broadway	South	From County Road west to the end of Willow Run Estates, from Piermont Road to east end of 32 Piermont Road property
Cresskill Avenue	West	From the start of the inside curve on the west side to the end of the inside curve on the west side and just south of Cottage Place on the southwest side 25 ft. from curb
East Madison Avenue	Both	From Piermont Road to County Road
Grant Avenue	Both	From Burns Place to Knickerbocker Road
Grant Avenue	Both	From west of Highland Street to approximately 150 feet east of the crosswalk at Brookside Avenue
Grant Avenue	Both	From bridge to 75 feet east of intersection of Cresskill Avenue

Grant Avenue	Both	From Cottage Place to Veterans Square
Lincoln Drive	East/West	From Cresskill Avenue to School Circle
Madison Avenue	Both	From Tenth Street to Piermont Road
Truman Drive	East	South of Pendergast Court to North of Eisenhower Drive

SECTION III:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

SECTION 263-33. Schedule II: No Parking Certain Hours.

In accordance with the provisions of Section 263-8, no person shall park a vehicle between the hours listed upon any of the following described streets or parts of streets:

Name of Street	Side	Hours/Days	Location
Brookside Avenue	Both	7:30 a.m. to 5:00 p.m. school days	From Bergen Terrace to Grant Avenue
Lexington Avenue	North	7:30 a.m. to 4:00 p.m. school days only	Between Brookside Avenue and Roosevelt Street

SECTION IV:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by deleting the following:

SECTION 263-34. Schedule III: No Stopping or Standing.

In accordance with the provisions of Section 263-9, no person shall stop or stand a vehicle between the times specified upon any of the following described streets or parts of streets:

Name of Street	Side	Hours/Days	Location
Dogwood Lane (Merritt Memorial School property)	West	All/All	From Margie Avenue south to the south school property line
Union Avenue	North	All/All	From east property line of 99 Union Avenue to east property line of 113 Union Avenue
Union Avenue	South	All/All	From west side of Hudson City Bank driveway (currently M&T Bank) to bus stop west of County Road

SECTION V:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

SECTION 263-34. Schedule III: No Stopping or Standing.

In accordance with the provisions of Section 263-9, no person shall stop or stand a vehicle between the times specified upon any of the following described streets or parts of streets:

Name of Street	Side	Hours/Days	Location
Margie Avenue	South	All/All	Piermont Road to Dogwood Lane

SECTION VI:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

SECTION 263-35. Schedule IV: Parking Time Limited.

In accordance with the provisions of Section 263-10, no person shall park a vehicle for longer than the time limit shown upon any of the following streets or parts of streets:

Name of Street	Side	Time Limit; Hours/Days	Location
Ackerman Avenue	West	2 hrs. weekdays 9 a.m. to 3 p.m.	Entire Length
Dogwood Lane	East	No parking anytime. Standing only	Between Borough Hall emergency entrance and Margie Avenue
Margie Avenue	Both	2 hrs. weekdays 9 a.m. to 3p.m.	Dogwood Lane to Ackerman Avenue
Union Avenue	Both	1 hour; 7:00 a.m. to 7:00 p.m./All	From Piermont Road to County Road where spots painted

SECTION VII:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

SECTION 263-39. Schedule VIII: Stop Intersections.

In accordance with the provisions of Section 263-14, the following described intersections are hereby designated as stop intersections:

Intersection	Stop Sign On
Eisenhower Drive and Truman Drive	Eisenhower Drive
Linwood Avenue and Palisades Avenue	Linwood Avenue, northbound
Truman Drive and Eisenhower Drive	Truman Drive, northbound
Woodland Road and Godfrey Place	Godfrey Place, southbound

SECTION VIII:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by deleting the following:

SECTION 263-45. Schedule XIV: Prohibited Turns at Intersections.

In accordance with the provisions of Section 263-20, no person shall make a turn of the kind designated below at any of the following locations:

Intersection

Prohibited Turn

Grant Avenue and Merrifield Way, eastbound
(1 sign, south side Grant Avenue; 1 sign, north side
Grant Avenue)

No left turn anytime

SECTION IX:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

SECTION 263-46. Schedule XV: Prohibited Right Turns on Red Signal.

In accordance with the provisions of Section 263-21, no person shall make a right turn when facing a steady red signal (stop indication) at any of the following locations:

Location

Prohibited Right Turn

Jefferson Avenue and Madison Avenue

No turn on red Monday – Friday
7:30 a.m. to 4:30 p.m.
School days

Union Avenue and Piermont Road
(east and west bound)

No turn on Red

County Road and Union Avenue

No turn on Red
7:30 a.m. to 4:00 p.m.

SECTION X

All other Ordinances of the Borough, or parts thereof, which are in conflict with this Ordinance, are hereby repealed to the extent of such conflict.

SECTION XI

If any section, subsection, paragraph, subdivision, or sentence of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such decision shall apply only to the section, subsection, paragraph, subdivision, sentence, clause, phrase or provision so adjudged, and the remainder of this Ordinance shall be deemed valid and effective.

SECTION XII

This Ordinance shall take effect immediately upon final passage and publication according to law.
