Mayor and Council

Regular Meetings on the first and third Wednesday of each month at 7:30 PM, with the exception of July and August when only the second Wednesday ordinarily shall be scheduled. If a meeting date falls on a State legal holiday, the meeting will be held the following day, unless otherwise designated in advance.

Committee of the Whole Meetings on the second Wednesday of each month at 7:30 PM. With the exception of July and August when it is scheduled for the first Wednesday. Formal action may or may not be taken.

Board of Health

Regular Meetings will be held at 8:00 PM on the following dates: Jan. 11, Mar. 22, June 28, Sept. 27, and Nov. 22.

Community Center Board of Trustees

Second Monday of each month at 8:00 PM. Meetings are held at the Cresskill Community Center, 100 3<sup>rd</sup> Street.

Municipal Pool Commission

Second Monday of each month at 7:30 PM, except July and August when it will be held at 8:00 PM.

Planning Board

Regular Meetings on the second and fourth Tuesdays of each month at 7:30 PM.

Zoning Board of Adjustment

Regular Meetings on the fourth Thursday of every month at 8:00 PM, with the exception of November, which will be held on December 2.

Recreation Committee

Regular Meetings second Wednesday of each month at 8:00 PM. No Meeting in August. Meetings are held at the Cresskill Community Center, 100 3<sup>rd</sup> Street.

Environmental Commission

Regular Meetings second Thursday of each month at 7:30 PM.

Library Board of Trustees
