If a meeting date falls on a State legal holiday, the meeting will be held the following day, unless otherwise designated in advance.

Committee of the Whole Meetings on the second Wednesday of each month at 7:30 PM. With the exception of July and August when it is scheduled for the first Wednesday. Formal action may or may not be taken.

Regular Meetings will be held at 7:30 PM on the following dates: January 23, March 27, June 26, September 25, and November 27.

Regular Meetings on the second Monday of each month at 7:30 PM.

Planning Board
