2017 REGISTRATION

ELIGIBILITY: Residents of the Borough of Cresskill, full-time employees, non-resident families sponsored by resident members, and those non-residents who pay local property taxes to the Borough of Cresskill, are eligible for membership in the municipal pool.

APPLICATION FOR MEMBERSHIP: Every application must be made in the name of an individual who meets the eligibility requirements and is at least 18 years of age. In the event of an individual membership application for a minor the application must be made in the name of the parent or guardian **EVEN THOUGH THE PARENT OR GUARDIAN IS NOT JOINING.** In each case the applicant should be the "head of household." The Municipal Pool Commission reserves the right to review proof of residency and such other documentation that may affect membership status.

TYPES OF MEMBERSHIP

Family: This membership may include two members residing at same address, one of whom must be an adult. This type of membership may also include any and all children who are unmarried and are between the ages of 3 and under 23 by Labor Day of the current swimming season. There is no charge for children under 3 years of age.

Individual: Any one person is eligible for an individual membership provided he/she meets the eligibility requirements above and is at least 16 years of age by Labor Day of the current swimming season. In the event that the individual is a minor the applicant shall be a parent or guardian as provided above under "application membership."

Senior Citizen: Any person who meets the above eligibility requirements and has reached his/her 62nd birthday by October 1st of the current swimming year may receive a senior citizen membership. In addition, the spouse/co-habitant of a senior citizen may receive this same type of membership even though the spouse/co-habitant may not have reached his/her 62nd birthday. Since this is *not* a family type membership, no children may be included in this type of membership.

Sponsored: At the discretion of the Pool Commission, a lottery may be held to offer membership for non-resident families, who are sponsored by members of the pool. If a member sponsors an individual or family, the sponsoring member's membership fees must be paid before the sponsored membership can be taken.
