AN ORDINANCE TO FIX THE SALARIES, WAGES AND COMPENSATION FOR THE FIRE DEPARTMENT OF THE BOROUGH OF CRESSKILL

BE IT ORDAINED by the Mayor and Council of the Borough of Cresskill in the County of Bergen and State of New Jersey, as follows:

<u>SECTION I</u> Purpose: Salaries and wages, longevity payments or other compensation provided for by terms of this Ordinance and Schedule 'A-1' listed below, are hereby fixed for the respective Fire Department of the Borough of Cresskill at the respective rates and sums shown herein, effective January 1, 2020 through December 31, 2023.

<u>SECTION II</u> Time of Payment: All salaries, wages, longevity payments or other compensation shall be paid in bi-weekly installments within the ranges and according to the conditions set forth in the Contract.

SECTION V

All other Ordinances of the Borough, or parts thereof, which are in conflict with this Ordinance, are hereby repealed to the extent of such conflict.

SECTION VI

If any section, subsection, paragraph, subdivision, or sentence of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such decision shall apply only to the section, subsection, paragraph, subdivision, sentence, clause, phrase or provision so adjudged, and the remainder of this Ordinance shall be deemed valid and effective.

SECTION VII

This Ordinance shall take effect immediately upon final passage and publication according to law.
